## ALASKA NATIVE CORPORATION CONTRACTING BENEFITS

### KOMAN BUSINESS ADVANTAGE

- ANCs are deemed to be socially and economically disadvantaged. 13 CFR 124.109(a)(2)
- ANCs are exempt from the competitive threshold. 13 CFR 124.506 (b); FAR 19.805-1 (b)(2)
- No restriction on the size of 8(a) “sole-source” awards to ANC-owned 8(a) program participants. A contracting officer who wants to make a sole-source award with a Total Contract Value in excess of \$100M for DoD (\$25M for civilian agencies) must submit a formal Justification & Authorization (J&A) in accordance with Agency SOPs. 13 CFR 124.506(b)(5); 13 CFR 124.502(b)(3)(c)(17)
- Sole source awards made to 8(a) firms cannot be protested per 13 CFR 124.517(a)(b). ANC 8(a) companies eligible for a sole source or competitive 8(a) requirement may not be challenged by another participant or any other party, either to SBA or any administrative forum as part of a bid or other contract protest.

### PAST PERFORMANCE

- As an ANC 8(a), KOMAN may claim the past performance of key management personnel and sister companies during the evaluation period of an award per FAR 15.305(a)(2)(iii).

### 8(A) SUBCONTRACTING

- Because 8(a) companies may subcontract portions of the work to other firms, KOMAN is able to assemble a perfect team for any particular project with other qualified companies.

### 5% INDIAN INCENTIVE PROGRAM:

- DoD Contractors who offer subcontracts to ANC firms receive a rebate of 5% of the total value of the subcontract as an incentive per Section 504 of the Indian Financing Act of 1974 (25 U.S.C. § 1544).
